This correspondence is in response to your Freedom of Information Act (FOIA) request dated and received in the Office of the Pardon Attorney (OPA) on 10/26/2016. Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552 *et seq.*, you requested clemency related correspondence filed or passed through the Office of the Pardon Attorney by or on behalf of Lawrence A. Franklin, Ivre Lewis Libby, Stewart David Nozette, and Jonathan Pollard since 2009.

In response to your request, I searched the official files of this office and determined that we do not have a clemency case file for Ivre Lewis Libby or Stewart David Nozette. We also do not have a case file for Mr. Pollard within the scope of your request. As a result, we have no documents to produce, there has been no fee assessed for the search of our records, and this will be our final correspondence in relation to that part of the above referenced request.

In relation to your request for records related to Mr. Lawrence A. Franklin, you did not return a signed Certificate of Identification from Mr. Franklin as indicated in my correspondence dated December 9, 2016, which would have granted this Office permission to disclose nonexempt documents from his clemency casefile, so I have determined that the entire file is exempt from disclosure pursuant to 5 U.S.C. § 552(b)(5), which concerns certain inter- and intra-agency communications protected by the deliberative process privilege, the attorney work-product privilege, the attorney-client privilege, the Presidential communications privilege; and 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
