This is in further response to your Freedom of Information Act (FOIA) request for access to records in the custody of the National Archives and Records Administration (NARA). On June 6, 2011, our office received your request for FBI File regarding Foundry Associates Incorporated-Neutrality Act; file number 2-HQ-875. This response is specific to the records that were referred to other government agencies for review.

We have received review decisions on 54 documents from other government agencies. We determined 15 of those documents may be released in full and 30 documents were released with portions redacted. Redactions were made on the basis of FOIA Exemptions (b)(1); (b)(3); (b)(6); and (b)(7)(D). Exemption (b)(3) pertains to information exempt from disclosure by statute. The relevant statute is the Central Intelligence Agency Act of 1949, 50 U.S.C. 403g, as amended, e.g., Section 6, which exempts from the disclosure requirement information pertaining to the organization, functions, including those related to the protection of intelligence sources and methods.

There were nine documents denied in full on the basis of FOIA Exemptions (b)(1) and (b)(3). The relevant statute is the Central Intelligence Agency Act of 1949, 50 U.S.C. 403g, as amended, e.g., Section 6, which exempts from the disclosure requirement information pertaining to the organization, functions, including those related to the protection of intelligence sources and methods.

If you are not satisfied with our response to your request, you may administratively appeal by writing to the Deputy Archivist of the United States (ND), National Archives and Records Administration, 8601 Adelphi Road, College Park, Maryland 20740-6001. The Deputy Archivist must receive you appeal within 35 days of the date of this letter. Clearly mark the appeal letter and envelope "FOIA Appeal" and cite your case number in your appeal letter. Please note that denials under the FOIA of access to national security information accessioned by NARA are made by designated officials of the originating or responsible agencies or by NARA under a written delegation of authority. We will coordinate FOIA appeals of denials to national security information with the equity holding agencies.

On April 4, 2012 we provided you with 32 documents that were released from your original request. Since your visit, we were able to release in full 13 additional documents. You or your representative can view the released materials in our research room here in College Park, MD. If you wish to order copies,

you can do so by check or money order made payable to the "National Archives Trust Fund," forward your payment with a completed copy of the enclosed quotation for reproduction services form (Form 72) to: National Archives Trust Fund, Cashier (BCT), Form 72 Order, 8601 Adelphi Road, College Park, Maryland 20740-6001. We only accept payments made in U.S. dollars and drawn from U.S. banks. If you prefer to pay using American Express, MasterCard, Visa, or Discover credit card, fax the completed form with your credit card information to 202-357-5906 or call the Accounts Receivable Specialist at 301-837-3720 and provide your credit card information. Retain one copy of the enclosed Form 72 for your records.

We are still awaiting review decisions from appropriate agencies completing further review on 21 additional documents. We will notify you as soon as we process the agency determinations on the documents you requested.
