1. The name of the corporation is ZIONIST ORGANIZATION OF AMERICA.
2. The date of the filing of the Certificate for ZOA was April 14, 1920.
3. ZOA was formed pursuant to a Special Law of 1920, Chapter 205, of the New York Legislature.
4. The Secretary of State is hereby designated as agent of ZOA upon whom process against it may be served.

5. Under §201 of the Not-for-Profit Corporation Law, ZOA is a Type A not-for-profit corporation as defined in this chapter.
6. By filing this Certificate of Type, ZOA elects to have the New York Not-for-Profit Law apply to it in all respects.
